**ORDINANCE NO. 18-06-01**

**PREVAILING WAGE ORDINANCE**

**WHEREAS**, the State of Illinois has enacted the Prevailing Wage Act, 820 ILCS 130/0.01 *et seq.*, (the “Act”); and

**WHEREAS**, the aforesaid Act requires that each public body in Illinois investigate and ascertain the prevailing rate of wages as defined in said Act and publicly post or keep available for inspection by any interested party in the main office of the public body its determination of such prevailing rate of wage;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Library Trustees of the Prospect Heights Public Library District; Cook County, Illinois;

**Section 1.** To the extent and as required by the Act, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workmen engaged in the construction of public works coming under the jurisdiction of the Prospect Heights Public Library District is hereby ascertained to be the same as the prevailing rate of wages for construction work in Cook County as determined by the Department of Labor of the State of Illinois as of June 2018, a copy of that determination being posted on the Department’s website. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor shall supersede the Department’s June, 2018 determination and shall apply to any and all public works construction undertaken by the Prospect Heights Public Library District. The

definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

**Section 2.** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works as defined in Section 2 of the Act, 820 ILCS 130/2.

**Section 3.** The Secretary of the Prospect Heights Public Library District Board of Trustees shall publicly post notice of this Ordinance for inspection by any interested party on the Library's website with a hyperlink to the Department's wage chart for Cook County. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to or otherwise referenced and incorporated in all contract specifications for public works as defined in the Act.

**Section 4.** The Secretary of the Prospect Heights Public Library District Board of Trustees shall mail a copy of this determination to any employer, to any association of employers, and to any person or association of employees who have filed their names and addresses requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**Section 5.** The Secretary of the Prospect Heights Public Library District Board of Trustees shall promptly file a certified copy of this Ordinance with the Department of Labor of the State of Illinois.

**Section 6.** This Ordinance shall be in full force and effect from and after its passage.


